## COMPETITIVE TENDER

### for the sale of Equestrian Monument Mujo Hrnjica in plaster

#### INTRODUCTION

The Equestrian Monument Mujo Hrnjica was made of plaster in 1993. Since the end of the war and until the announcement of this Competitive Tender, the government in Bosnia and Herzegovina, on all levels, has behaved poorly in regards to the Monument of the epic folk hero Mujo Hrnjica. Certain government levels even had a goal to demolish the stated Monument. During the war, the Monument suffered some damage, and unfortunately, due to poor conditions in which it is placed, it suffered additional damage. With his own resources, and with the help of colleagues from Croatia, the author of the Monument repaired the most critically threatened damage points on the monument. In order to save it from decay, the author wrote, begged and sought help for years from all relevant institutions in Bosnia and Herzegovina, but to great disappointment, without any results. The local government in particular has showed itself to be completely inert, since it didn't allocate a single convertible mark for the conservation of the Monument. Having in mind all of the above, and especially due to the damage of the plaster model that is spreading, the Monument could suffer total destruction. The author, who cannot finance the conservation and repair alone, has decided to announce the Competitive Tender for the sale of the Monument.

#### THE GOAL OF THE TENDER

The goal of the sale of the Equestrian Monument is the permanent repair and conservation of the Monument, and to protect it from decay and destruction. The author is willing to perform all sculpting on the restoration and conservation of the Monument from 1993.

#### DIMENSIONS OF THE MONUMENT

Dimensions of the Monument are impressive: 10,5 m in length, 3,5 m in width, and 8,5 meters in height, which makes it one of the biggest equestrian monuments in the EU and the world.

#### ARTISTIC VALUE OF THE MONUMENT

The Author owns the original documentation on the artistic-sculpting value of the Monument, signed by the relevant institutions and individuals – world renowned sculpturers and professors at the Academy of Arts in the Republic of Croatia. The documentation is available to all interested parties upon request.

#### THE RIGHT OF PARTICIPATION

The Competitive Tender is international and all physical and legal entities from the territory of the EU and the world have the right of participation.

#### APPLICATION PROCEDURE

All interested parties need to send a written confirmation expressing their wish to participate in the Competitive Tender for the purchase of the Monument. In addition, they confirm that they wish to come to Velika Kladuša and see the document in situ, without exemptions. The phone number for contact is +387 62 35 09 11. The authorized person for information is solely the author and owner of the Monument Zlatko Dizdarević.

#### TENDER DURATION

The Competitive Tender is open until the sale of the Monument, and the author will inform about this the public via media in due time.

#### PRESERVATION OF ANONYMITY

All interested parties deliver their intention exclusively in a written form and confirm that they wish to participate in the stated Tender. With this act the parties will acquire anonymity as the interested parties in the tender procedure for the purchase of the Monument. The most favourable bidder acquires the right to complete anonymity, and can decided differently on the information for the public according to their own wishes.

#### TAKING THE DOCUMENT, PACKAGING AND TRANSPORT

Due to the size of the Monument, a certain time period is necessary to cut the plaster model into segments, which the buyer and the owner will agree upon. Depending on the address of the buyer of the Monument, the manner of packaging of the Monument segments will also be agreed upon. The transport will be done in accordance with the legal regulations of Bosnia and Herzegovina or the home country of the Monument buyer.

#### PURCHASE VALUE OF THE MONUMENT

The documents pertaining to the artistic-sculpting value of the Monument can be submitted to all potential buyers for review, upon seeing the plaster model of the Monument. The documents are issued and certified by the relevant art institutions from the Republic of Croatia. The purchase value of the Monument is solely the subject of the personal verbal agreement between the author and the buyer of the Monument, and the most favourable bidder.

Note: the purchase value of the Monument is symbolic compared to the artistic value of the Monument. All financial transactions will be performed by credit transfer on the bank account of Atelier Dizdarević at Raiffeisen Bank Velika Kladuša.

#### TRANSFER OF OWNERSHIP OF THE MONUMENT

After the agreed upon purchase price and a down payment, it is necessary to sign the Contract of the Transfer of Permanent Ownership and Copyright of the Monument. All necessary documents are certified in the relevant government institutions of Bosnia and Herzegovina.

It is a prestige to be the owner of one of the biggest equestrian monuments in the world. Therefore, welcome to Bosnia and Herzegovina and Velika Kladuša with a sole and clear purpose and a noble intention to save a highly valuable monument and an authentic artwork from destruction with mutual forces, a monument that belongs to the European and world cultural heritage.
